#### T&Cs:

- 1. Dog Health and Safety
- Female dogs showing signs of coming into heat or in heat are not permitted to walk in group walks. Dog owner must notify sniff 'n' stroll and other services might be offered.
- •All dogs must be up to date on core vaccinations (including kennel cough), flea and worm treatments.
- Dogs with contagious illnesses or parasites cannot be walked until cleared by a vet.
- Dogs must wear a fitted collar with an ID tag showing the owner's name and address. Dogs also must have a tracker on, in which the owner can see their dogs location.
- 2. Leash and Control Policy
- I agree for the use on longlines on walks, unless in a designated secure area or field, owners dog can be let off. Unless the owner has given permission for dog(s) to be off leash and the walker feels it's appropriate.
- Dogs showing aggression or unreliable recall will remain on lead at all times.

### 3. Group Walks

- No more than 4-6 dogs walked at once per walker to ensure safety and control. As per insurance policy.
- Only compatible and socialised dogs will be walked together.
- 4. Cancellations and Scheduling
- Cancellations less than 24 hours before the scheduled walk may incur a fee £5 first time.
- All walks are scheduled in advance and subject to availability.
- 5. Pick-Up and Drop-Off
- Owners must provide clear instructions for accessing the home and details of any special needs or behaviour issues within the home environment.
- Scheduled pick-up and drop-off times will be agreed in advance. Please allow 30mins either side of pick ups and drop offs if your dog is in a group walk session.
- 6. Bad Weather Policy
  - Walks may be shortened or rescheduled in extreme weather to protect the dogs' welfare.

### 7. Emergency Procedure

- Owners must provide contact information and an emergency vet contact.
- In the event of illness or injury, the walker will contact the owner immediately and seek veterinary care if necessary.

#### 8. Restricted Breeds and Behaviour

• Dogs subject to the UK's Dangerous Dogs Act or any with a history of aggression must be declared before walks are arranged. It is down to the walkers discretion whether or not to take owners dog on.

### 9. Waste and Cleanup

- All mess created by dogs will be picked up and disposed of in accordance with local laws.
- · Walkers will carry waste bags and clean up after each dog.

#### 10. Insurance

- The company is fully insured for public liability and pet care.
- ·Walker is a certified first aid trained.
